



## The Growing Stage - Group Contract

***Please read the following rules carefully. By signing, you agree to the following:***

1. Groups of 10 or more will receive a 10% discount on regular ticket prices, no ticket fees, and reserved seating. Group pricing is as follows:
  - Adult: \$25 each
  - Senior (62 and over): \$20 each
  - Youth (17 and under): \$16 each
2. Each group must have one designated group representative. The group representative will sign the contract, make the payment, and be responsible for picking up the tickets on the day of the performance. Only the group representative may make changes to the group order.
3. Payment in full and exact numbers for your group are due two weeks prior to the performance date. Payment may be made by check (*payable to "The Growing Stage"*) or credit card. Split payments are not permitted.
4. **Tickets are non-refundable. Once payment has been submitted, no refunds will be issued.** If you have to cancel your reservation, all attempts will be made to reschedule. We cannot issue partial refunds.
5. If you need to add more tickets to your group after payment has been submitted, please notify the Box Office as soon as possible to ensure that we can accommodate them. Payment will be due at the time of notification and all additions are based on availability.
6. Group tickets are held at the Box Office and are available starting 1 hour prior to showtime. In order to seat your group, the group representative must be present to pick up the tickets. Arrive at least 15 minutes in advance to ensure your seat reservations.
7. **We do not allow outside food or drink in our theatre.** Please ask about our current concessions policy.
8. Review our current Health and Safety policies in advance. The group representative is responsible for making sure the entire group is aware of these policies before they arrive at the theatre.
